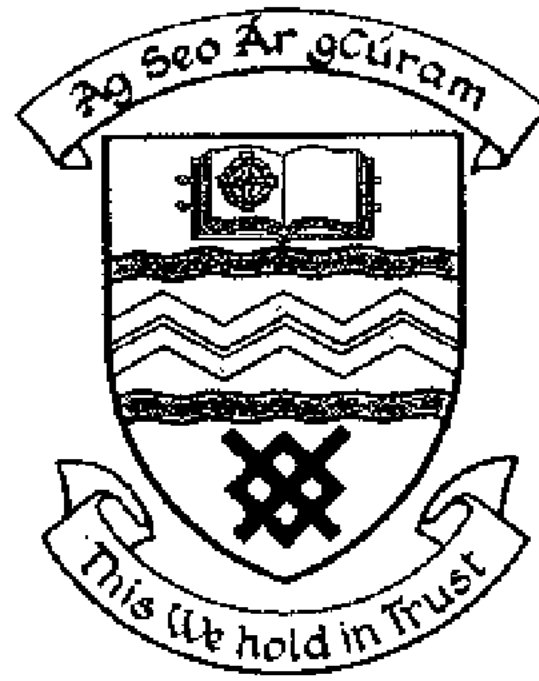

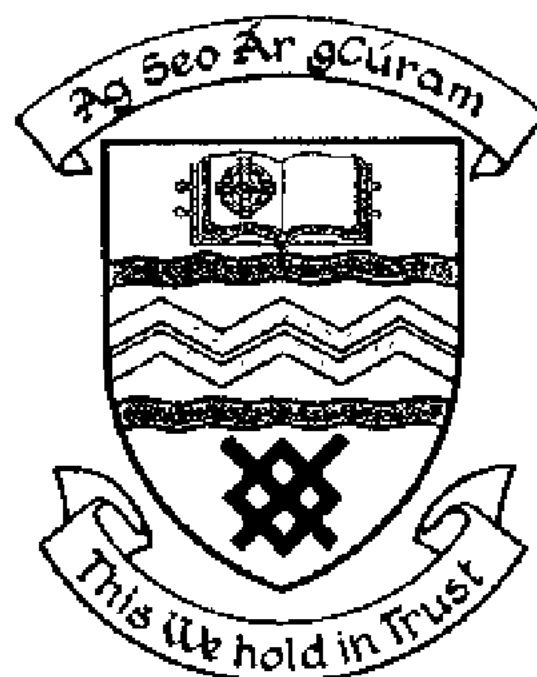

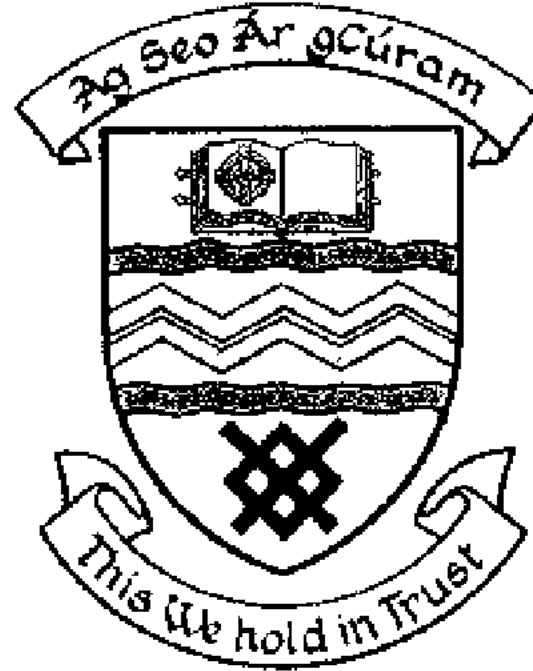

**Conditions and Reasons**

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.  
REASON:  
To ensure that the development shall be in accordance with the permission, and that effective control be maintained.
- 2 That the entire premises be used as a single dwelling unit.  
REASON:  
To prevent unauthorised development.
- 3 That all external finishes harmonise in colour and texture with the existing premises.  
REASON:  
In the interest of visual amenity.
- 4 Only clean uncontaminated surface water shall be discharged to the public surface water sewer. All foul waste shall be discharged to the public foul sewer.  
REASON:  
In the interest of public health.
- 5 The front boundary wall with No. 22 shall be capped and plastered along its entire length.  
REASON:  
In the interest of visual amenity.
- 6 The front wall of the proposed extension - exclusive of the ground floor projecting portion shall be erected along a building line established by drawing a straight line between the front corner of the existing house and the front corner of the adjacent house, No. 22.  
REASON:  
In the interest of the proper planning and development of the area and visual amenity.

NOTE: Applicant is advised that in the event of encroachment or oversailing of the adjoining property, the consent of the adjoining property owner is required.
