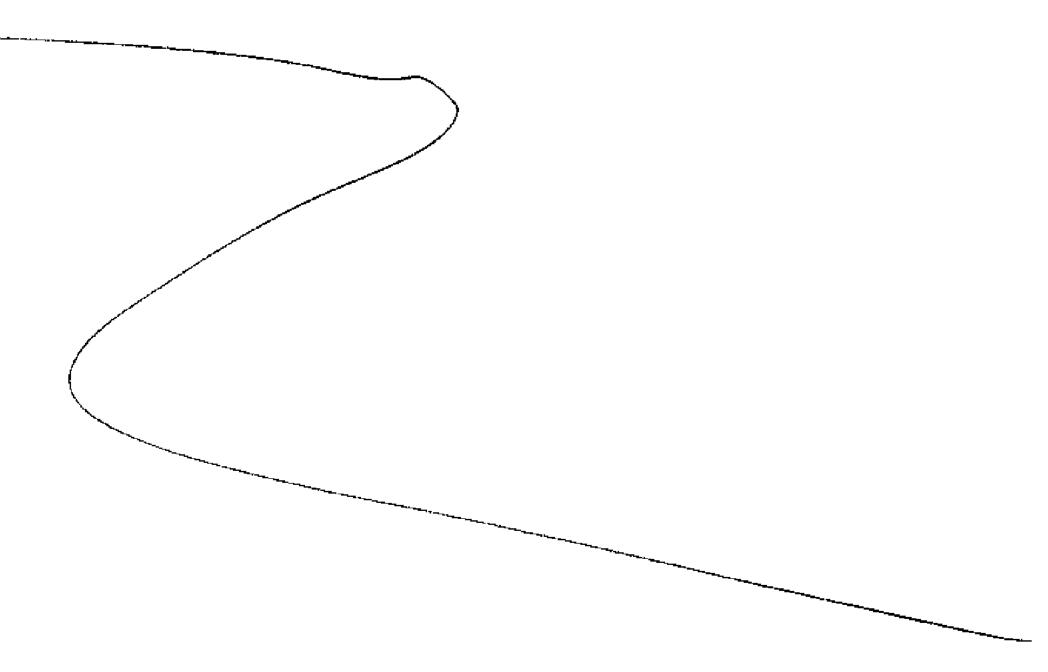

Reasons
