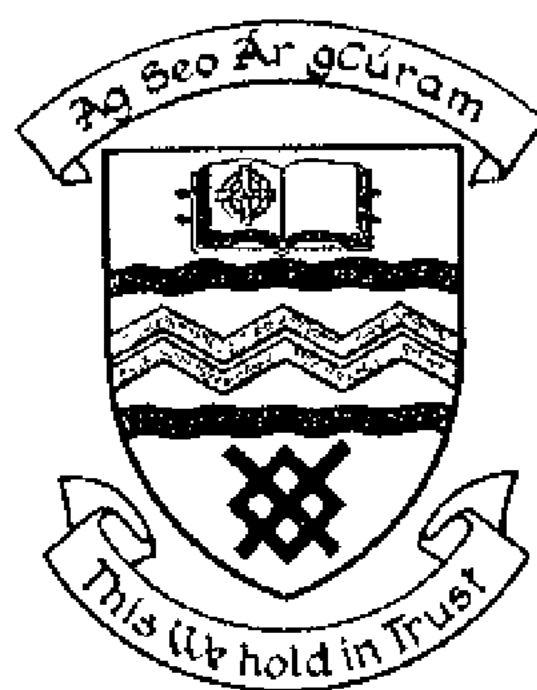

With reference to your planning application, received on 03/04/98 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following **ADDITIONAL INFORMATION** must be submitted in quadruplicate:

- 1 The applicant is requested to submit a site layout plan indicating the site fully outlined in red that is in the applicants legal ownership. The site layout should also include exact location of the boundary wall and route of drain and location of existing trees which adjoin the site in the public open space.
In the event that it is proposed to encroach on the public open space the applicant is requested to submit evidence of legal entitlement to do so (The applicant is advised to consult with the Parks and Landscape Services Department, South Dublin County Council in this regard).
- 2 The applicant is requested to submit details of the existing drain in respect of pipe sizes, gradients etc. and how the proposed development may effect this drain. (The applicant is advised to consult with the Environmental Services Department in this regard).
