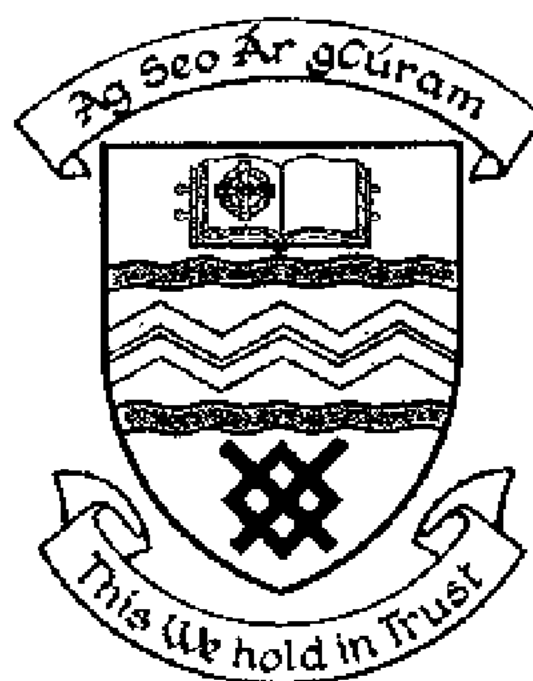

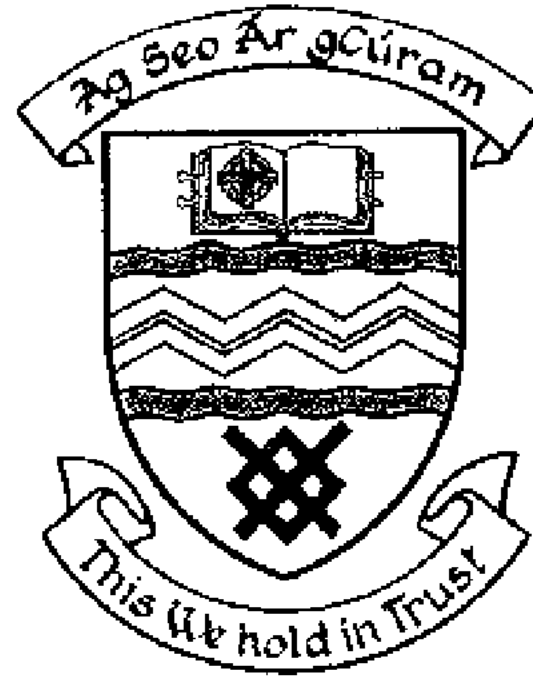

- 1 The development to be retained in its entirety in accordance with the plans, particulars and specifications lodged with the application.
