Reasons

- The proposed extension which is larger than the existing dwelling is excessive in scale and height and out of proportion with the existing dwelling. It does not harmonise and integrate with the existing dwelling in roof profile and fenestration detail and would be visually obtrusive, incongruous and out of character with the surrounding residential development. The proposed development would be seriously injurious to residential development and would devalue property in the vicinity and as a result would be contrary to the proper planning and development of the area.
- The lodged plans are inaccurate in that windows shown on the floor plans do not correspond with windows shown in elevations.
