2. That the existing structure shall be removed and the use of the site terminated before the 31st. August 1984, unless before that date permission for its retention is granted by the Planning Authority or by An Bord Pleanála on appeal.
3. That the requirements of the Chief Fire Officer be ascertained and be strictly adhered to in the development.
4. That the use of the site be ancillary to the normal functions of the service station.
6. That the overall service station site including the site of this application be tidied within two months and maintained in a satisfactory condition.

REASONS FOR CONDITIONS

1. To ensure that the development shall be in accordance with the permission and that effective control be maintained.
2. To enable the effects of the development on the amenities of the area to be reviewed, having regard to the conditions then obtaining.
3. In the interest of safety and the avoidance of fire hazard.
