Reasons

- The site of the proposed development is located in an area zoned with the objective to protect and provide for the development of agriculture in the 1993 Dublin County Development Plan. The proposed development which is in the nature of a second dwelling unit on site, would contravene materially the development objective indicated in the Development Plan and would, therefore, be contrary to the proper planning and development of the area.
- The site of the proposed development is located on a rural road substandard in width, capacity, alignment and surfacing. The proposed development would give rise to additional traffic and turning movements on this substandard road which would endanger public safety by reason of traffic hazard.
- 3 The proposed development would be prejudicial to public health for the following reasons:
 - (a) no details of the existing water supply have been provided;
 - (b) a site plan indicating the position of the biocycle unit and irrigation areas has not been submitted;
 - (c) results from site tests prescribed by SR6:1991 published by EOLAS have not been submitted,
 - (d) the proposal to discharge additional surface water to a roadside drain is not acceptable.
