

AN BORD PLEANÁLA

APPEAL by Mark Kelly of 7 The Mall, Lucan, County Dublin against the decision made on the 26th day of March, 1998 by the Council of the County of South Dublin to refuse permission for the retention of palisade fencing to rear boundary of 7 The Mall, Lucan, County Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1998, permission is hereby refused for the retention of the said palisade fencing to the rear boundary for the reason set out in the Schedule hereto.

SCHEDULE

The boundary of the site adjoins the riverside walk which is an important public amenity close to the weir within Lucan village. The fencing which it is proposed to retain is visually obtrusive and seriously detracts from the amenities of the area. It is considered that the retention of the palisade fence is contrary to the proper planning and development of the area.
