Reasons

- The grant of permission for the existing and proposed development by reason of, roof design, elevational treatment, additional front entrance, site layout and relationship with the existing house is incongruous with the character and orderly development of the area and would seriously injure the amenities and depreciate the value of property in the vicinity.
