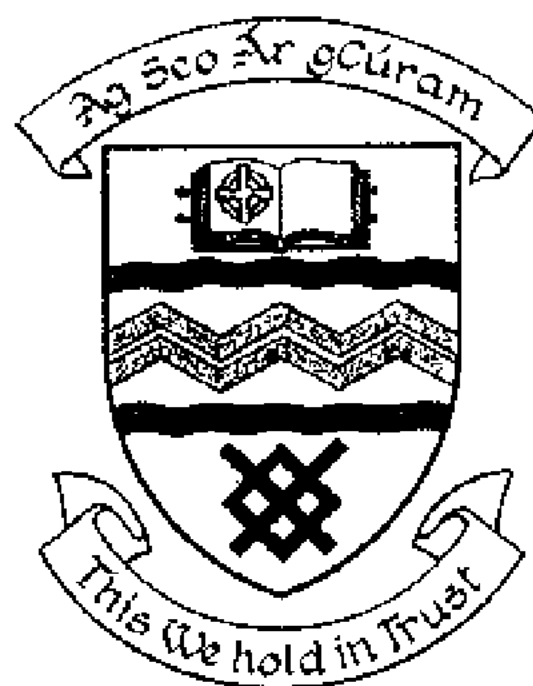

Reasons

- 1 It is considered that the proposed development constitutes an undesirable intensification of a non-conforming use and as such would materially contravene the zoning objective for the area, i.e. zoning objective 'A' 'To protect and/or improve residential amenity' and as such would not be in the interests of the proper planning and development of the area.
- 2 It is considered that the proposed development by reason of the provision of inadequate carparking would constitute overdevelopment of this restricted site and as such would be harmful to the residential amenities of the area and would not be in the interests of the proper planning and development of the area.
