## Reasons

- The proposed development when taken in conjunction with the existing creche use on the site would constitute a significant commercial activity within a residential area and would result in a significant increase in the number of children to be accommodated, increased vehicular movements to and from the site and increased noise levels and would therefore seriously injure the amenities and depreciate the value of property in the vicinity.
- Having regard to the size of the proposed development when taken in conjunction with the existing creche facility on site and to the proposal to cease the residential use of the dwelling house, it is considered that the proposal would materially contravene the zoning objective, "to protect and/or improve residential amenity", and would be contrary to the policy of the council in relation to home-based economic activities, as set out at paragraph 2.2.8 of the South Dublin County Development Plan 1998, and would be contrary to the proper planning and development of the area.
