Reasons

- Having regard to the size of the proposed development, the number of children to be accommodated, the increased vehicular movements to and from the site and the noise which would be generated from the activity the proposed development would seriously injure the amenities and depreciate the value of property in the vicinity.
- Having regard to the zoning objective for the site 'A' to protect and/or improve residential in the 1998 South Dublin County Development Plan and the fact that the proposed development by virtue of its size and the number of children to be accommodated constitutes a substantial commercial activity, the proposed development would materially contravene an objective of the Development Plan and would be contrary to the proper planning and development of the area.
- Having regard to the deficiency in the off-street car parking provision within the proposed development it is considered that the proposal would materially contravene a development objective of the 1998 South Dublin County Development Plan, with regard to the parking provision and would be seriously injurious to the amenities of property in the vicinity.
- The details pertaining to the foul and surface water drainage are deemed to be inadequate to facilitate a proper assessment of the proposal.
