





Reasons

- 1 It is considered that the proposed signage by reason of both its form, scale, excessive level of illumination and free standing form where applicable would be seriously injurious to the visual amenities of the area and contrary to the proper planning and development of the area.
- 2 It is considered that the proposed signage would contravene advertising policies as set out in the 1998 South Dublin County Development Plan, which in general seek to minimise non essential advertising signs and to limit the number of signs located on any property. The policy further states that the purpose of signs is to guide the public/customers and not to intrude severely on visual amenity.
- 3 The multiplicity of signs and the nature and number of light sources on the site would cause considerable distraction to motorists having regard to the location of the site in a prominent location beside a heavily trafficked junction of a motorway and a national Primary Road. It is considered that the proposal would constitute a serious traffic hazard.
- 4 The works which have been carried out and are applied for in this application contravene condition No. 12 of the parent planning permission granted on foot of application S97A/0002 by Order No. 0436 dated 04/03/97
