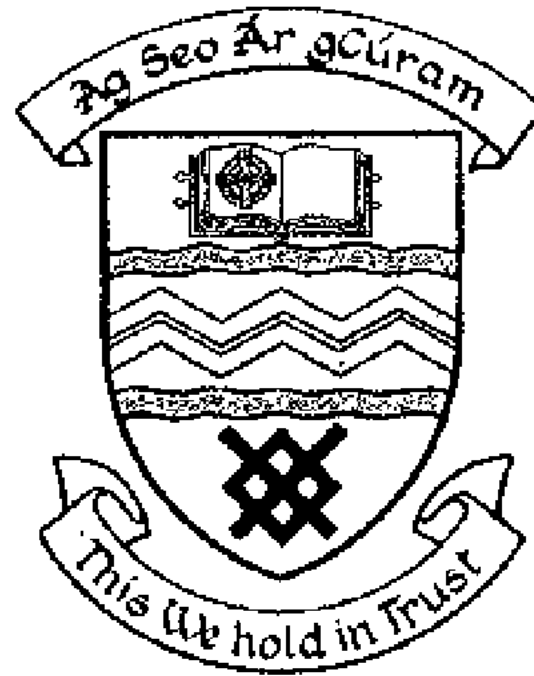

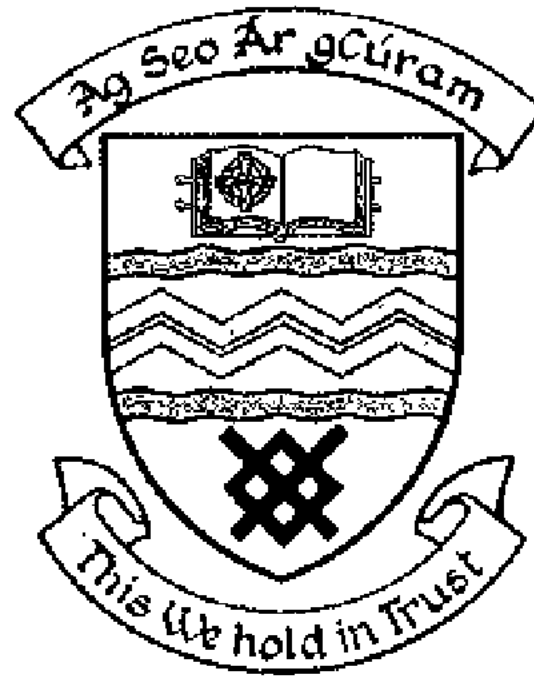

- 2 That the existing palisade fencing mounted on the boundary wall shall be removed within one month following installation of the proposed fan ends.

REASON:

In the interest of amenity.

- 3 That the proposed fan ends shall be finished using a suitable paint colour or alternative colour finish compatible with the existing boundary treatment to the public road.

REASON:

In the interest of visual amenity.

- (1) All buildings must be designed and constructed in accordance with the Building Regulations 1991 amended 1994.
- (2) Building Control Regulations require a Commencement Notice. A copy of the Commencement Notice is attached.
- (3) A Fire Safety Certificate must be obtained from the Building Control Authority, where applicable.
- (4) Free Standing Walls must be designed and constructed in accordance with IS 325: Code of Practice for use of Masonry Part 1 : Structural use of unreinforced Masonry. The Owner must also ensure that the construction of all walls is supervised by a competent person.

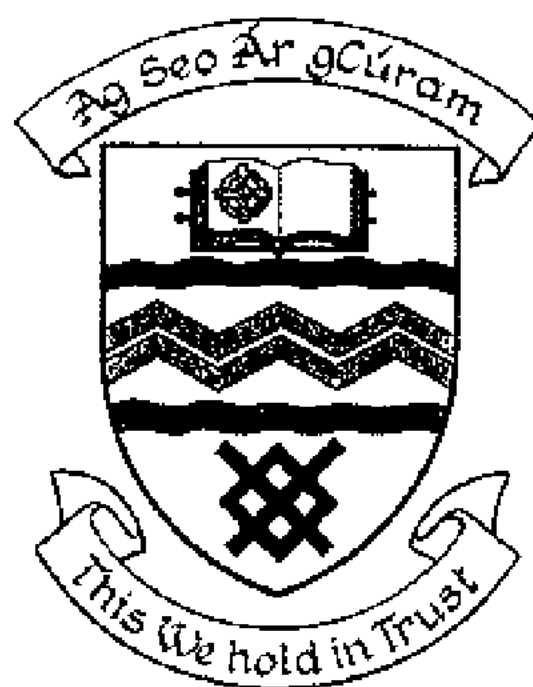

NOTE: The applicant is further advised that palisade fencing is not generally acceptable in this location and that any proposed railing shall be of a decorative type only.

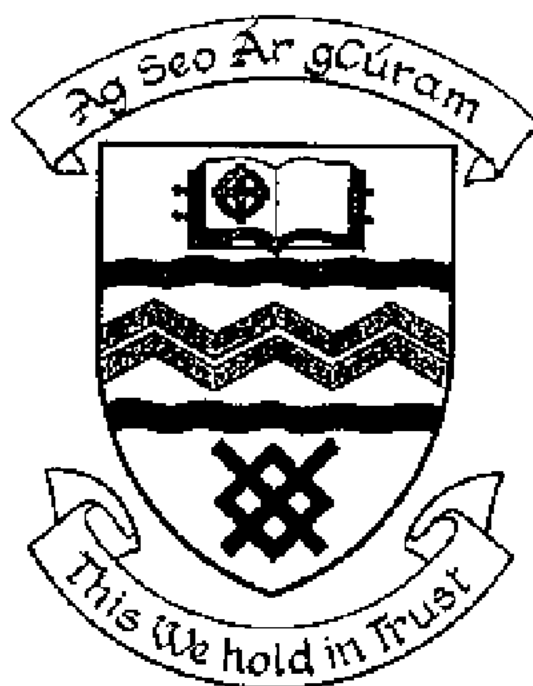
