

Reasons

- By virtue of its narrow width and inadequate separation from the existing house, and its siting well forward of the established building line at Bancroft Avenue, the proposed development would have a cramped and obtrusive appearance and would be inconsistent with the layout and character of the area. It would therefore seriously injure the residential amenity of property in the vicinity and would contravene materially the zoning objective for the area, which is "to protect and/or improve residential amenity.
- According to County Council records the site of the proposed dwelling house is traversed by an existing 300mm diameter surface water sewer. The proposed development would encroach upon this sewer and would be prejudicial to public health.
