Reasons

- Having regard to the zoning provisions of the 1993 Dublin County Development Plan and to the fact that permission has been granted for a number of houses on the lands of which the application site formed part, it is considered that the proposed development would contravene materially the provisions of the Development Plan and would be contrary to the proper planning and development of the area.
- The proposed development constitutes undesirable ribbon development in an unserviced rural area which would lead to demands for the uneconomic provision of public services and communal facilities which would set an undesirable precedent for further similar developments in the area.
- The proposed development would endanger public safety by reason of traffic hazard due to additional turning movements generated on a substandard rural road network at an access where visibility is substandard.
- The proposed development would be prejudicial to public health as the applicant has failed to establish the suitability of the soil for the disposal of domestic effluent.
