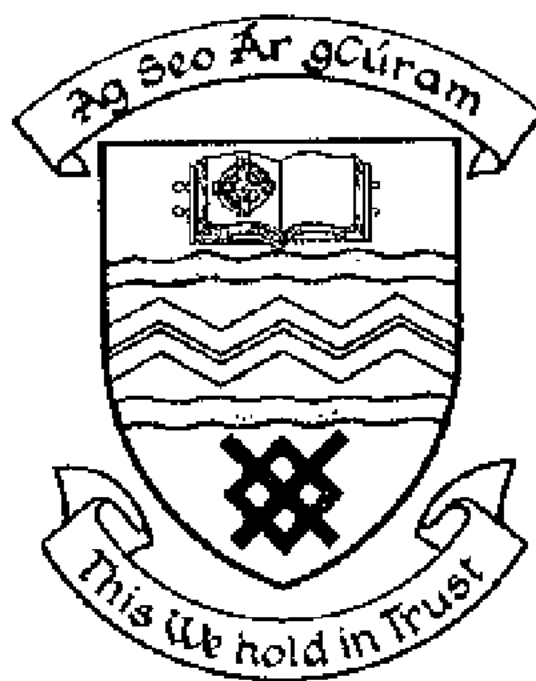

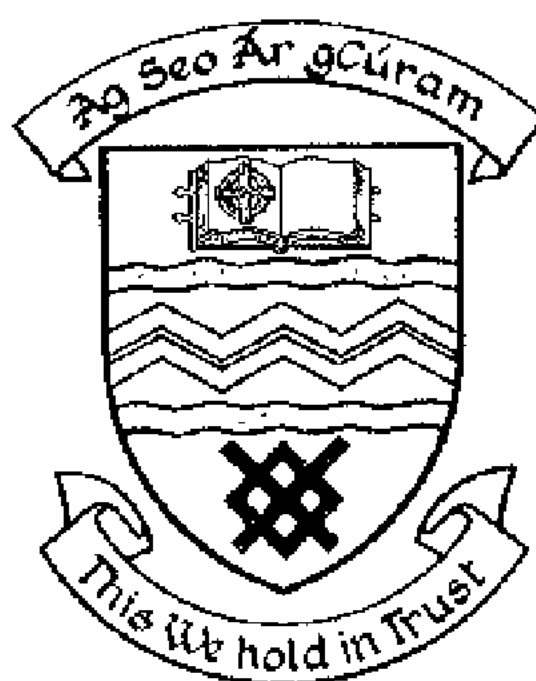

**Conditions and Reasons**

- 1 That the arrangements made with regard to the payment of financial contributions and lodgement of security in respect of the overall development, as required by Condition No's. 6, 7, 8, 9, 10 and 11 of Register Reference 93A/1161 (An Bord Pleanála Order No. PL.06S.093483) be strictly adhered to in respect of this development.

**REASON:**

It is considered reasonable that the developer should contribute towards the cost of providing services and to ensure that a ready sanction may be available to the Council to induce the provision of services and prevent disamenity in the development.

In the interest of the proper planning and development of the area.

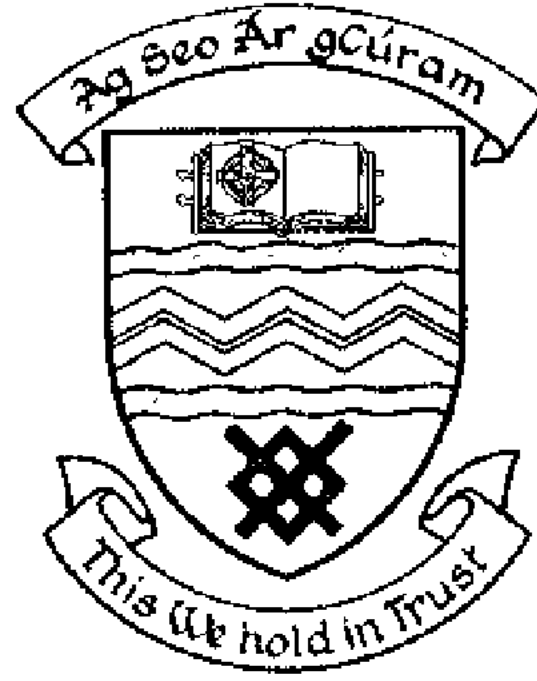

So that the retail useage within the overall development does not exceed the maximum area of 23,500sq.m. permitted according to the Dublin County Development Plan, 1993 and in the interest of the proper planning and development of the area.
