Reasons

- The proposed development would contravene materially a development objective indicated in the Dublin County Development Plan 1993 for the use solely or primarily of particular areas for particular purposes i.e. zoning objective 'B' "To protect and provide for the development of agriculture" in the Dublin County Development Plan 1993.
