

## Reasons

- The proposed development would materially contravene the policies set out in paragraph 3.5.6 of the Dublin County Development Plan 1993 regarding private open space provision around dwellings in that the proposed rear garden length falls considerable short of the minimum distance of eleven metres required.
- The proposed setback of the dwelling would materially infringe the existing building line which would be seriously injurious to the residential amenity and would devalue property in the vicinity by reason of overlooking and loss of privacy.
- The existing sewerage system serving the area is seriously overloaded and there is no capacity to serve additional development due to lack of dilution within the receiving stream which accepts the treated effluent from the Newcastle Treatment works. The proposed development would therefore be premature by reason of the said deficiency in the provision of public piped sewerage facilities and the period within which such deficiencies may reasonably be expected to be made good.
- The submission does not include any details of the proposed arrangements for surface water drainage to serve the development.
