APPEAL by Michael Casey of 185 Aylesbury Estate, Tallaght, County Dublin against the decision made on the 14th day of July, 1983, by the Council of the County of Dublin to refuse permission for the construction of a new vehicular entrance at 185, Aylesbury Estate, Tallaght, County Dublin.
