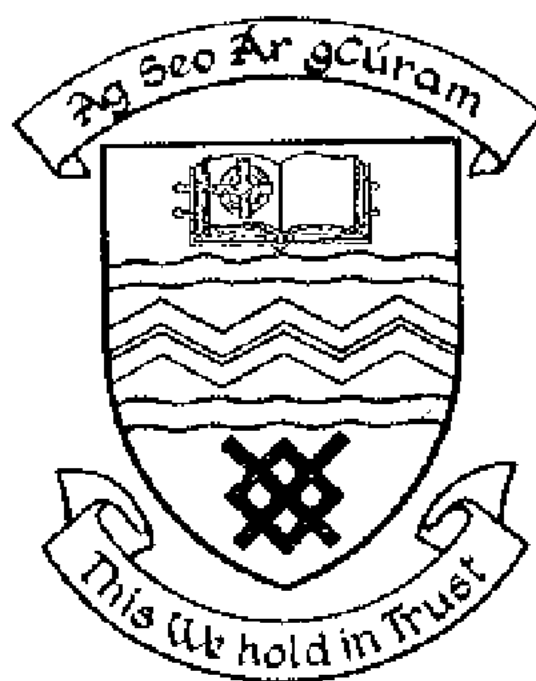

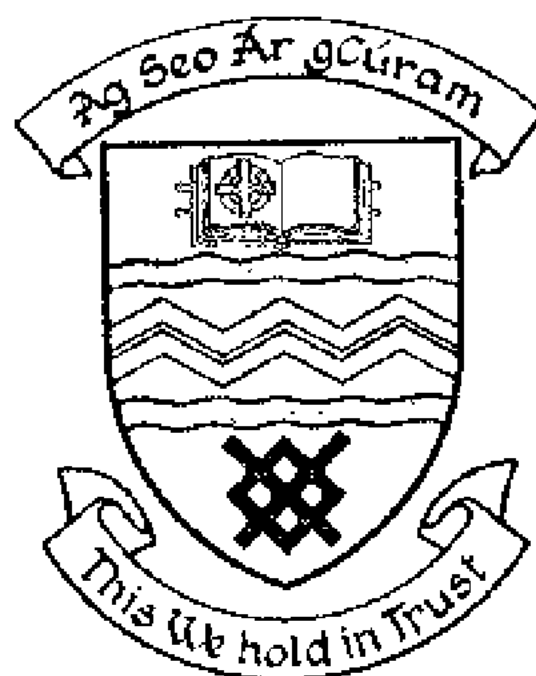

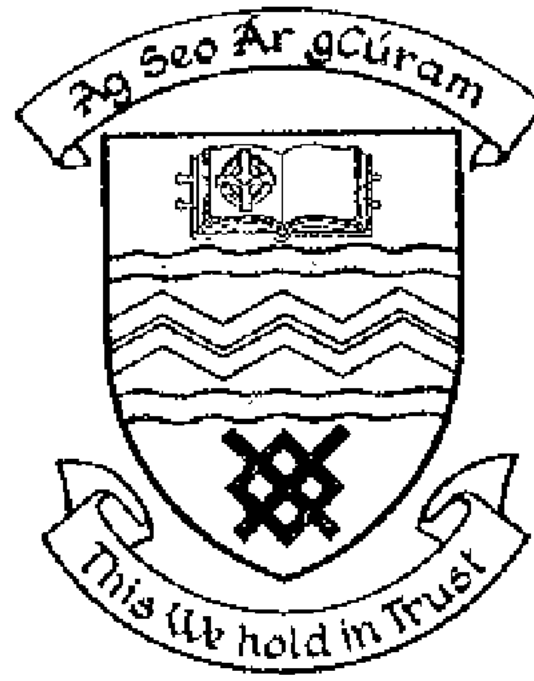

- 7 The shelter shall be relocated slightly further north so as to ensure that the side panel of the shelter is set back a minimum distance of 3 metres from the kerb.

**REASON:**

To avoid the obstruction of vision to road users or from the nearby junction.

- (1) All buildings must be designed and constructed in accordance with the Building Regulations 1991 amended 1994.
- (2) Building Control Regulations require a Commencement Notice. A copy of the Commencement Notice is attached.
- (3) A Fire Safety Certificate must be obtained from the Building Control Authority, where applicable.
- (4) Free Standing Walls must be designed and constructed in accordance with IS 325: Code of Practice for use of Masonry Part 1 : Structural use of unreinforced Masonry. The owner must also ensure that the construction of all walls is supervised by a competent person.

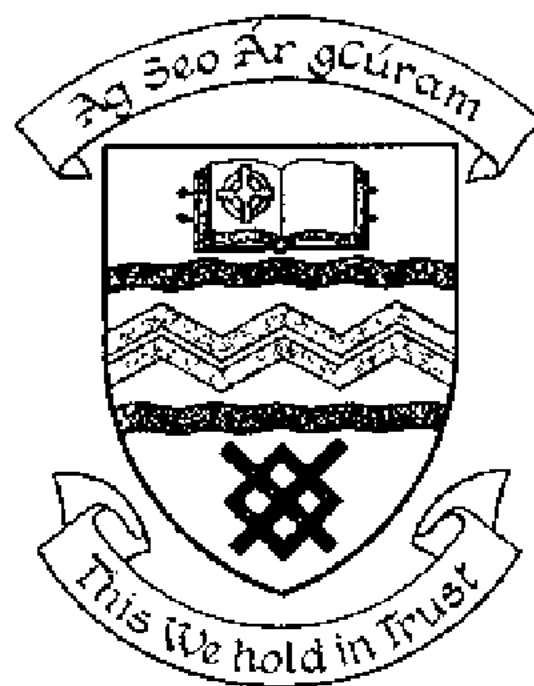

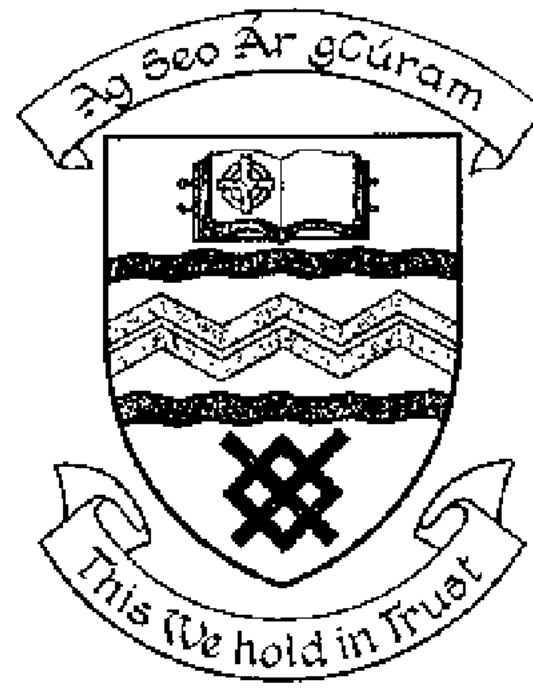

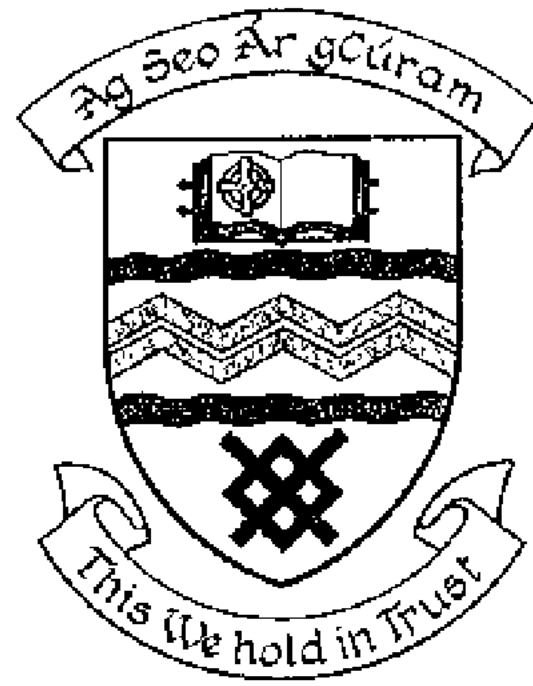
