

Reasous

- The design of the proposed house is seriously out of character with the design of houses in Willbrook Estate. The proposed development would, therefore, be seriously injurious to the residential and visual amenities of the area.
- The applicant has failed to provide a 2.3m separation between opposing gable walls to provide a 1.15m side passage for each house as set down at section 3.5.11 of the Dublin County Development Plan 1993. The proposed development would therefore be contrary to the proper planning and development of the area.
- The proposed development comes within 3m of an existing 150mm diameter watermain which runs adjacent to the site. The proposed development would therefore be prejudicial to public health and would be contrary to the proper planning and development of the area.
