The proposed development would endanger public safety by reason of traffic hazard due to the generation of additional traffic turning movements on a heavily-trafficked road which is inadequate in carriageway width and where there are no footpaths or public lighting. The proposed development would, therefore, be contrary to the proper planning and development of the area.
