Reasons

The proposed signage by reason of its excessive size, form of illumination, lack of integration in design terms with the building and taken together with signage previously granted on this building would be injurious to the visual amenities of the area and contrary to the proper planning and development of the area.

2 The proposed signage would set an undesirable precedent for other similar developments along the Naas Road, particularly internally illuminated signage advertising corporate logos,

which would in themselves and cumulatively not be in the interests of the proper planning and development of the area.

3

The proposed signage would contravene Development Plan policy with respect to advertising signage, as contained in the South Dublin County Development Plan, 1993 and the Draft South Dublin County Development Plan 1998. These policies generally state that advertising signage where permitted should be simple in design and that the number of signs located on a property should be limited and not unduly obtrusive. The policy also states that the purpose of signs is to guide the public/customers and not to intrude severely on visual amenity and that control will be exercised to prevent the impression of clutter in any location.
