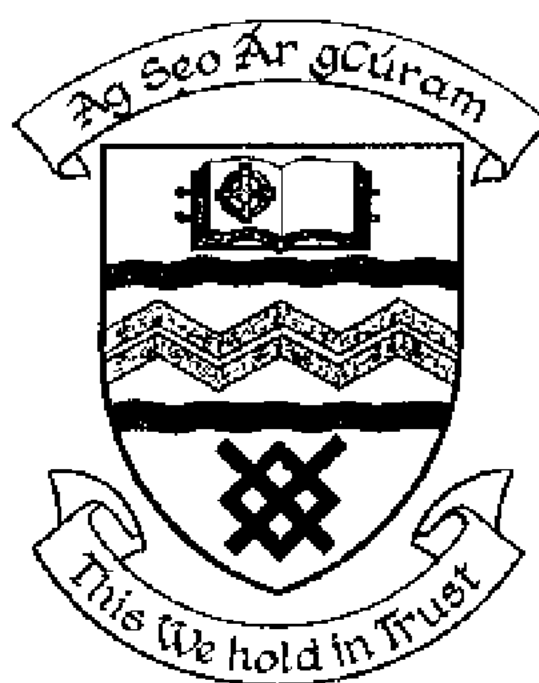

**Reasons**

- 1 The proposed advertising structure would contribute to visual clutter close to a major traffic junction which would constitute a distraction to drivers and would be prejudicial to public safety. The proposed development would not therefore be in accordance with the proper planning and development of the area.
- 2 The proposed advertising structure appears to be located on land outside the applicants control or ownership, and the consent of the owners to the making of the application and erection of the structure has not been established.
