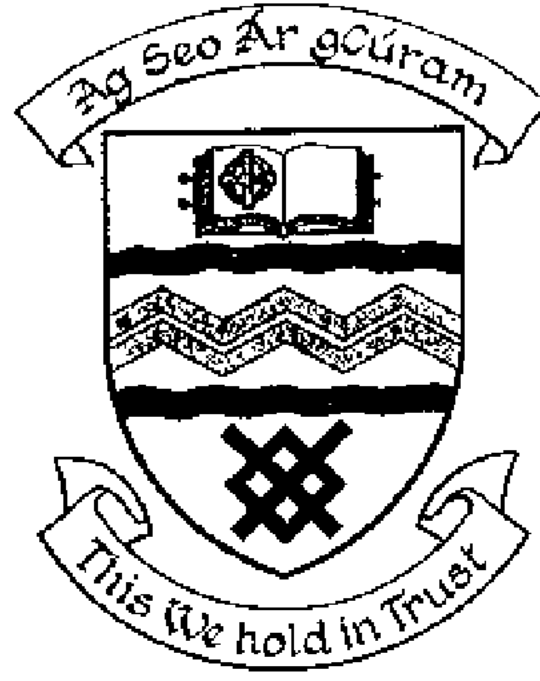

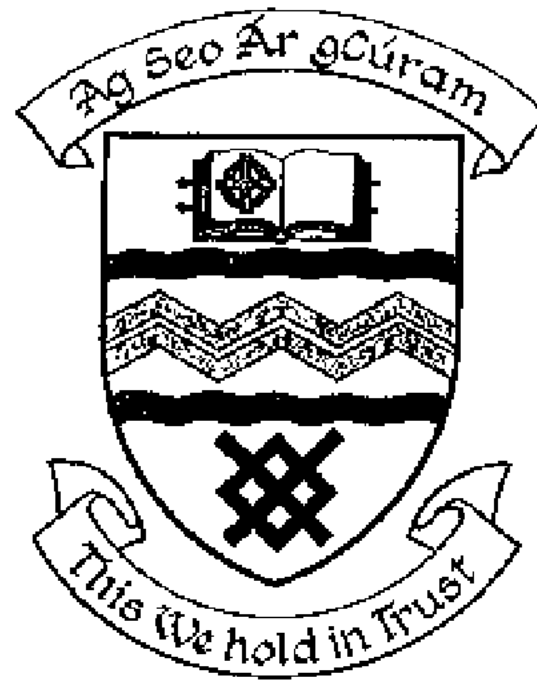

Reasons

- 1 The proposed development will lead to an increase in traffic, and particularly heavy vehicles on a substandard road network which is connected to the Naas Road (N7 National Primary Road) at a hazardous junction, and will endanger public safety by reason of a traffic hazard.
- 2 The proposed development would create an undesirable precedent for further similar development on this site on a permanent basis contrary to the zoning objective which is "to protect and provide for the development of agriculture", and would not be in accordance with the proper planning and development of the area.
