DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1998, permission is hereby refused for the said development for the reasons set out in the Schedule hereto.

SCHEDULE

- 1. The proposed development is located in an area zoned "B" in the current Development Plan for the area, for which the objective is "to protect and provide for the development of agriculture". This objective is considered to be reasonable. It is a policy of the planning authority, as set out in the plan, to channel housing into serviced centres and to restrict development in rural areas to that necessary to serve the needs of those engaged in agriculture and other rural activities. The proposed development would contribute to ribbon development in this area, lead to demands for the uneconomic provision of public services and community facilities in an area where these are neither available nor proposed, interfere with the rural character and attractiveness of the area and would, therefore, contravene materially the development objective as set out in the Development Plan and be contrary to the proper planning and development of the area.
- It is considered that the proposed development would endanger public safety by reason of traffic hazard because of the additional traffic turning movements it would generate on a road which is substandard in terms of width and alignment.

Reasons

- The proposed development would contravene materially the development objective indicated in the current development plan for the area for the use solely or primarily of the area for agricultural purposes. It is the policy of the planning authority as set out in the development plan to restrict housing development in the area to applicants with a genuine need to reside in proximity to their employment where related to the rural community or reasons of close family ties with the rural community. It is considered that the applicant does not come within the scope of this housing need criteria. The proposed development would, therefore, be contrary to the proper planning and development of the area.
- The proposed development constitutes undesirable ribbon development in a rural area, lacking certain public services and community facilities which would create a demand for the uneconomic provision of further services and facilities.
- The proposed development would endanger public safety by reason of traffic hazard arising from the substandard nature of the existing access road and poor sight visibility on a steep gradient. The proposed development would, therefore, be contrary to the proper planning and development of the area.
- The proposed development would be contrary to the proper planning and development of the are as the proposed site does not meet with the minimum 60m road frontage requirement as set out in Section 33.15 of the 1993 Dublin County Development Plan.
