## Reasons

- The proposed development of a second house on this site unrelated to agricultural use or need would contravene materially a development objective of the 1993 Dublin County Development Plan for the use primarily of the site for agricultural purposes. The proposed development would result in haphazard one-off housing on agricultural lands which would injure the rural character of the area.
- The existing exit on to the public road is substandard with poor sight visibility and is located at a point where there is an unbroken white line in the centre of the road. The generation of additional turning movements would endanger public safety by reason of traffic hazard.
- The proposed development constitutes undesirable ribbon development on a substandard rural road network which would lead to a demand for the uneconomic provision of services and would set an undesirable precedent for further similar developments in the area.
- The site of the proposed development does not comply with the minimum road frontage requirements of the Planning Authority as set down at section 3.3.15 of the 1993 Dublin County Development Plan. The proposed development would, therefore be contrary to the proper planning and development of the area.
