## Reasons

- The design of the proposed house is not in-keeping with the design of houses in Kiltipper Close. The proposed development would, therefore, be seriously injurious to the residential and visual amenities of the area.
- The applicant has failed to provide a 2.3m separation between opposing gable walls to provide a 1.15m side passage for each house as set down at section 3.5.11 of the 1993 Dublin County Development Plan. The proposed development would, therefore, be contrary to the proper planning and development of the area.
- The drawings submitted with the application do not indicate the location of a public foul sewer located in the Firhouse Road West road reservation. The proposed house is within 5.0m of this sewer. The proposed development would, therefore be prejudicial to public health and contrary to the proper planning and development of the area.
