Reasons

- The proposed development will result in additional traffic movements on a narrow laneway with no footpaths and where access vision is very substandard and as such would endanger public safety by reason of traffic hazard. The development would result in on-street car parking in the area.
- The proposed development would set an undesirable precedent for other similar developments on this substandard rear laneway which would tend to lead to serious traffic congestion.
- The proposed development by reason of its backland location, inadequate separation from existing dwellings in the vicinity and potential overlooking and inadequate provision of private open space, would constitute substandard disorderly development and would seriously injure the amenities of and depreciate the value of property in the vicinity. The standards laid down in the Development Plan regarding depths of front and rear gardens cannot be complied with.
- The proposed development would be at variance with the prevailing density and character of development in the area and as such would be contrary to the proper planning and development of the area.
