Reasons

- The footprint of the proposed dwelling extends by a distance of six metres beyond the rear of the existing dwelling, and the remaining rear garden depth is five metres. The proposed development is therefore substandard and would materially contravene paragraph 3.5.6(i) of the Dublin County Development Plan, 1993 regarding private open space provision around dwellings. As a result the proposed development would be contrary to the proper planning and development of the area.
- The proposed design of the dwelling by reason of the site coverage, shape, design roof profile and external finishes is considered to be visually obtrusive and incongruous and out of character with the pattern of the existing surrounding residential development. As a result the proposed development would be seriously injurious to and would devalue property in the vicinity which would be contrary to the proper planning and development of the area.
