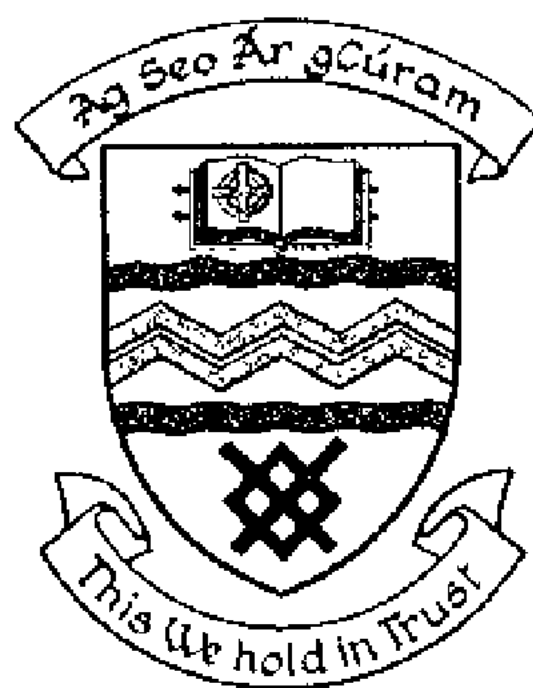

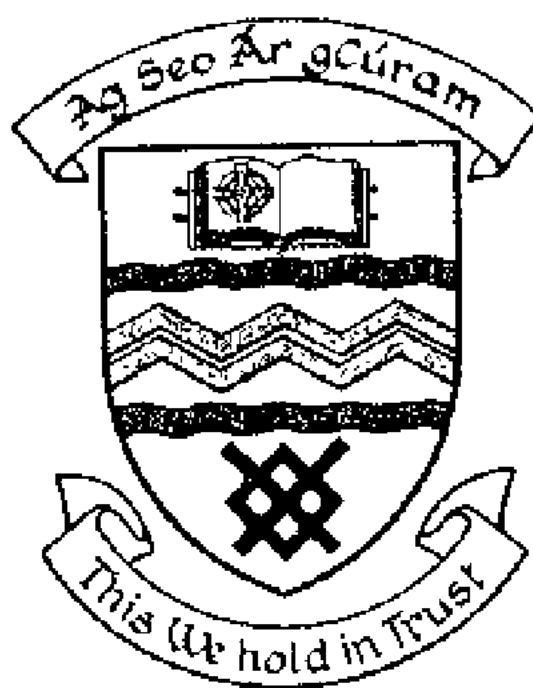

**Reasons**

- 1 The proposed storage shed would seriously injure the amenities of property in the vicinity.
- 2 The proposed development would contravene materially the zoning objective for the area which is 'to protect and improve high amenity areas' and as such, would be contrary to the proper planning and development of the area.
- 3 The proposed development would endanger public safety by reason of traffic hazard caused by additional turning movements on a substandard rural road network.
- 4 The proposed development would be prejudicial to public health for the following reasons:-
  - a) no satisfactory proposals for the disposal of surface water from the shed and the yard area have been submitted;
  - b) no site assessment proposals from the manufacturer/supplier of the 'BIOCYCLE' unit have been submitted.
