
- The proposed development by reason of it's height, position and design would be seriously injurious to the amenity value of the Round Tower which is included on List One for preservation and conservation on the Dublin County Development Plan, 1993. As a result the proposed development would materially contravene the Dublin County Development Plan, 1993.
- The proposed development would seriously interfere with the Round Tower which is included in the Register of Historic Monuments under Section 5 of the National Monuments (Amendment) Act, 1987.
- The proposed development by reason of its height, position and design does not integrate with the pattern and design of surrounding residential development and would give rise to overshadowing and overlooking of adjoining residential properties. As a result the proposed development would be seriously injurious to residential amenity and contrary to the proper planning and development of the area, and depreciate the value of property in the vicinity.
- The proposed access on the north side of the tower onto Tower Road which is one-way from the south is substandard due to lack of visibility. As a result the proposed development would endanger public safety by reason of traffic hazard.
