DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1998, permission is hereby refused for the said development for the reasons set out in the Schedule hereto.

SCHEDULE

- 1. The site is located in a rural area for which the zoning objective set out in the current development plan for the area is "to protect and provide for the development of agriculture", which objective is considered to be reasonable. It is the policy of the planning authority, as set out in the development plan, to restrict development to suitable sites in such rural areas where the applicants can establish a genuine need to reside in proximity to their employment where related to the rural community, or by reasons of close family ties with the rural community. It is considered that, the proposed development would not come within the scope of housing need criteria as set out in the development plan. Accordingly, the proposed development would contravene materially the said development objective and would, therefore, be contrary to the proper planning and development of the area.
- The proposed development would result in the encroachment of random housing on a highly elevated and prominent site where views of the development would be exposed in an northerly direction. The proposed development would be an unduly obtrusive feature in the landscape which would be out of character with and seriously injure the visual amenity of this scenic rural area with its sensitive and vulnerable landscape. The proposed development would, therefore, be contrary to the proper planning and development of the area.
