Reasons

- The site of the proposed development is zoned 'B', i.e., "to protect and provide for the development of agriculture", in the 1993 County Development Plan. The development therefore, would contravene materially a development objective indicated in the Development Plan for the use primarily of this area for agricultural purposes. It would, therefore, be contrary to the proper planning and development of the area.
- The proposed development would contribute to random housing development is an unserviced rural area remote from communal services and would, accordingly, give rise to demands for the uneconomic provision of public services and communal facilities.
- The proposed development would give rise to an excessive housing density on this land holding and would set an undesirable precedent for further subdivision of lands and consequent over development in the area zoned 'B', "to protect and provide for the development of agriculture".
