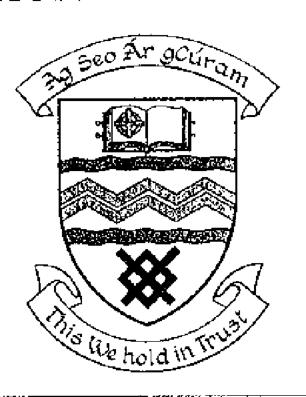

#### Reasons

- The drawings submitted with this application are inadequate in that the ESB sub-station, pedestrian laneway and houses to the rear fronting in to Pinetree Grove have not been indicated. The proposed development would, therefore, be contrary to the proper planning and development of the area.
- The proposed development would infringe an existing building line established by the gable wall of the existing house and the front walls of houses to the rear of the site in Pinetree Grove.
- The proposed development would be contrary to the proper planning and development of the area for the following reasons:
  - a) the proposed rear garden at 8.6m in length does not meet with the minimum requirement of 11.0m length;
  - b) the existing and proposed house are not 2.3m apart with the intervening space divided equally between the two for maintenance access;
  - c) the proposed house is within 1.0m of the side boundary wall.
  - d) the height of the side boundary wall of the site is in contravention of permission ref. S96B/0118 which stipulated a maximum height of 2.4m.
- The proposed development would be prejudicial to public health as the proposed house is within 5.0m of an existing public surface water sewer located adjacent to the side boundary of the site.
