APPEAL by Catherine Lynch, care of Liam J. Lynch of Coolmine, Saggart, County Dublin against the the decision made on the 23rd day of March, 1984, by the Council of the County of Dublin to refuse a permission for the erection of a house on a site at Coolmine, Saggart, County Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1983, permission is hereby refused for the erection of the said house for the reason set out in the Schedule hereto.

SCHEDULE

The site is located in an area where the objective of the planning authority, as expressed in the Dublin County Development Plan, is to protect and provide for the development of agriculture. This objective is considered reasonable and the proposed development would conflict with it and would militate against the preservation of the rural environment.
