Reasons

The site is zoned F 'to preserve and provide for open space and recreational amenities in the Dublin County Development Plan, 1993. An increase in the number of dwellings on the site as proposed (within which there is an existing intensive non-conforming use) close to existing single storey dwellings abutting the eastern site boundary, constitutes substandard overdevelopment of the site which is exarcerbated by the lack of separate private open space and car parking provision for the dwellings. As a result the proposed development would be seriously injurious to residential amenity, would devalue property in the vicinity and would be contrary to the proper planning and development of the area.
