Reasons

- The site is located in an area with the zoning objective to protect and provide for the development of agriculture, as indicated in the 1993 Dublin County Development Plan. The proposed development does not meet the housing need criteria in relation to development in such an area, would contravene materially this objective as set out in the development plan and would be contrary to the proper planning and development of the area.
- The proposed development would constitute undesirable ribbon development on a substandard road which would lead to demands for the uneconomic provision of services. The proposed development would, therefore, endanger public safety by reason of traffic hazard and would be contrary to the proper planning and development of the area.
- The proposed development would be prejudicial to public health for the following reasons:
 - a) the applicant has failed to submit evidence of the suitability of the soil for the disposal of domestic effluent;
 - b) the applicant has failed to indicate the location of the proposed well on the site layout plan;
 - the applicant has failed to indicate the location of wells, watercourses, septic tanks and percolation areas on adjoining lands;
 - the applicant has failed to indicate what waste water treatment unit is to be used, its size, and manufacturers/suppliers site specific tests.
