Reasons

- The proposed development represents overdevelopment of this site resulting in rear garden depths of 3.1 metres. The development as such would be in contravention of section 3.5.6 of the 1993 Development Plan and would be seriously injurious to the amenities and depreciate the value of property in the vicinity.
- The proposed development has a front building line of 1.5 metres from the estate road and 9 metres from the Local Distributor Road. Having regard to the fact that it is the front of these buildings it is considered that the set backs are inadequate and would lead to intrusive noise levels in the proposed houses.
- The proposed access road is 5.5 metres carriageway with a 1 metre footpath. This does not conform to any Road standard and would not be taken in charge. It is contrary to Council policy to allow such developments as proposed unless the roads have a standard of development to allow them to be taken-in-charge.
