

## Reasons

- The proposed development causes an unacceptable level of noise pollution to the surrounding area due to the barking of dogs when in the kennels and out in the runs and there are no feasible and satisfactory mitigating measures which can be introduced to ameliorate this problem.
- The proposed development by reason of the additional traffic and turning movements on the substandard road network associated with the development on the substandard rural road network serving the site endangers public safety by reason of traffic hazard.
- There is no residential accommodation within this premises. Accordingly the premises would be operated by person or persons living elsewhere. The operation of the premises by people living elsewhere could give rise to difficulties arising when the premises is not occupied by human staff. In this regard it is considered unlikely that the Planning Authority would be favourably disposed to the grant of a permission for a house on this small site.
