Reasons

- The proposed development by reason of density, design and impact on the streetscape would be incongrous with the prevailing pattern and character of development in the area and would seriously injure the amenities and depreciate the value of property in the vicinity. It would not be consistent with the zoning objective 'to protect and improve residential amenity and would not be consistent with the proper planning and development of the area.
- The proposed development by reason of inadequate set back from the boundary and proximity to a public watermain would not be consistent with the proper planning and development of the area. In this regard no building will be allowed within 5 metres of the 100mm diameter watermain in the footpath.
- Roads Engineer requires a 2 metre building line set back from road boundary. The proposed development does not provide for such a set back of building line.
