for the following reasons:

1. The advertising structure dwarf statutory road signs and compete for the attention of motorists thereby causing a traffic hazard.
2. The site of the structures is located in an area zoned "to protect and/or ~~xxx~~ improve residential amenity" in the Development Plan. The retention of these large, obtrusive advertising structures would contravene materially the above objective, and would not be in accordance with the proper planning and development of the area and would seriously injure the amenities of the area.
