SCHEDULE

The proposed development would, therefore, be contrary to the proper planning and development of the area.

Reasons

- The proposed development would contravene materially a development objective indicated in the Dublin County Development Plan 1993 for the use solely or primarily of particular areas for particular purposes i.e. zoning objective B; to protect and provide for the development of agriculture.
