

Conditions and Reasons

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.
REASON:
To ensure that the development shall be in accordance with the permission, and that effective control be maintained.
 - 2 That the entire premises be used as a single dwelling unit.
REASON:
To prevent unauthorised development.
 - 3 That all external finishes harmonise in colour and texture with the existing premises.
REASON:
In the interest of visual amenity.
 - 4 That the water supply and drainage arrangements, including the disposal of surface water, be in accordance with the requirements of the County Council.
REASON:
In order to comply with the Sanitary Services Acts, 1878-1964.
 - 5 That the proposed new door in the front elevation be omitted from the development. Provision to be made at ground floor level for a door access between the existing house and the proposed ground floor extension. Details to be agreed prior to commencement of development.
REASON:
In the interest of the proper planning and development of the area.

 - (2) Building Control Regulations require a Commencement Notice. A copy of the Commencement Notice is attached.
