

Reasons

The proposed development would contravene materially conditions, 1, 10, 11 and 15 of decision to grant planning permission on this site Ref. s96A/0034 which state as follows:-

Condition No. 1:

"The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application as amended by additional information received on 14/05/96 and clarification of additional information received by the Planning Authority on 22/7/96, save as may be required by the other conditions attached hereto:

REASON:

To ensure that the development shall be in accordance with the permission and that effective control be maintained".

Condition No.10:

"The roadside boundary hedgerow/stone wall shall be removed and the front boundary of the site set back 6.0 metres from the centre-line of the existing carriageway. The strip between the edge of the carriageway and the new boundary shall be levelled and grassed. No development within this area shall exceed a height of 0.9 metres. All underground or overhead services and poles shall be relocated, as may be necessary, to a suitable location adjacent to the new boundary at the developers expense. REASON:

In the interest of traffic safety."

Condition No. 11:

"The new entrance gate shall be recessed 1.5 metres from the new boundary with wing walls splayed at 45 Page 2 of 3
