

The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.

REASON:

To ensure that the development shall be in accordance with the permission, and that effective control be maintained.

- That all external finishes harmonise in colour and texture with the existing premises.

  REASON:
  - In the interest of visual amenity.
- Only clean uncontaminated surface water shall be discharged to the public surface water sewer. All foul waste shall be discharged to the public foul sewer.

  REASON:

  In the interest of public health.
- All first floor gable elevation windows of the proposed extension shall be in obscure glazing.
