Dear Sirs,

With reference to your planning application received here on 4th March, 1983, in connection with the above, I wish to inform you, that before the application can be considered under the Local Government (Planning and Development) Acts, 1963-1982, the following additional information must be submitted in quadruplicate:-

1. The applicants to indicate by way of revised drawings the full extent of the lands in their ownership adjacent to the site.
2. The applicants to indicate, by way of additional drawings to the full extent how their lands are affected by the adjoining road reservations for the Killeen Road, Naas Road and proposed Nangor-Fox and Geese Road.
3. The applicants to indicate if they are in a position to improve the seriously inadequate access between their site and the Naas Road (i.e. via the Killeen Road) and to submit definite proposals for same acceptable to the Council's Roads Department.
Note: Applicants are advised to consult with the Council's Roads Department.
4. The applicants to submit an acceptable scheme of foul and surface water drainage and water supply. In particular, details of foul sewer and water connection, details of proposed water consumption and acceptable calculations of surface water run-off.
Note: Applicants are advised to consult with the Council's Sanitary Services Department.
5. Applicants to submit an acceptable scheme of landscaping incorporating definite proposals for screening of the backs of proposed buildings from nearby existing and future roads.
