With reference to your planning application received here on 4th March, 1983, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963-1982, the following additional information must be submitted in quadruplicate:-

- 1. Clarification of the site curtilage boundaries of the proposed international service Industrial Park in relation to the overall site of this estate development.
- 2. Clarification of the proposed uses of each of the proposed units. Details of the proposed areas of each unit to be utilised for factory, warehousing, offices workshop, laboratories etc., are to be submitted,
- 3. As submitted plans indicate that the proposed structures are to be used exhusively to offices, the applicants are to clarify how the proposal relates to the zoning objective of the site which is "to provide for industry and related uses".
- 4. Clarification of the availability of off street car parking and adequate vehicular circulation areas (in accordance with Development Plan Standards) in relation to this proposed development.
- 5. The applicants to submit full and adequate details of the proposed foul and surface water drainage layout. Applicants are also to indicate on plan proposals for the diversion of an existing 225mm foul sever which affects the site.
- 6. Details of a comprehensive programme for the landscaping of the site including all boundary treatments proposed.

7. Applicants to clarify if the proposed amendments to previously approved site layout plan refer to the undefined site of the proposed International Service Industrial Park on the overall estate layout approved under a number of permissions granted on these lands. If the amendments refer to the latter, the following details are required:-

a. The approved layout referred to.

b. Details of amendments made to road layout, site curtilages, structures, approved, parking areas etc.
