With reference to your planning application received here on 4.3.83 in connection with the above, I wish to inform you, that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 - 1982, the following additional information must be submitted in quadruplicate:-

1. The applicant should submit a block plan of the site at 1:500 scale indicating the existing and proposed developments and additionally car parking and service areas to serve both the existing and proposed developments.
2. It is the opinion of the Planning Authority that the location of the "Site Notice" is unsatisfactory relative to the proposed development. The site notice should be located on the Palmerston Road frontage of the premises in a prominent position in accordance with the regulations of the Local Government (Planning and Development) Acts, 1963 - 1982.
3. Details of the boundary treatment and affect of proposed development on adjoining properties are required.
